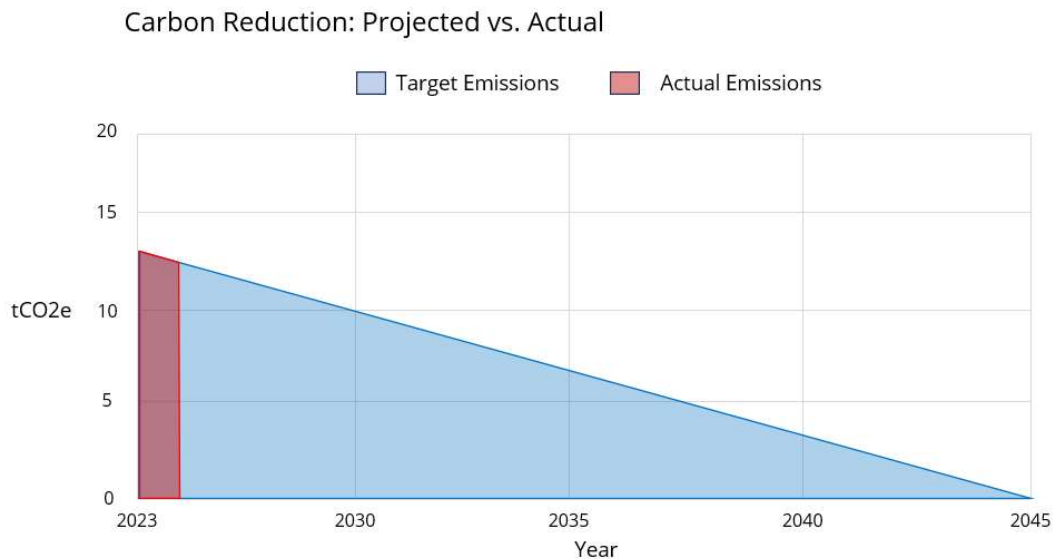


Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

Riskaware Ltd have adopted an Electric car scheme in September 2023 to encourage those staff which commute in cars may be incentivised to drive electric vehicles. In addition to this Riskaware in September 2023 joined the Cycle to Work scheme to encourage employees to cycle to work where possible. We project that carbon emissions will decrease over the next seven years to **10 tCO₂e** by 2030. This is a reduction of **25%**.

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2023 baseline. The carbon emission reduction achieved by these will be measured and published at the end of FY 23/

Riskaware Ltd have adopted a flexible working culture enabling employees to work from home up to 3 days per week, this will reduce the commute and the office-based emissions. Riskaware has also adopted an Electric car scheme in September 2023 to encourage those staff which commute



in cars may be incentivised to drive electric vehicles. In addition to this Riskaware in September 2023 joined the Cycle to Work scheme to encourage employees to cycle to work where possible. In the future we hope to implement further measures such as:
